

Privacy Notice

Background

Premier Energy is committed to ensuring your personal information is protected. This privacy notice describes how Premier Energy, the data controller, collects, uses and protects your information.

How we collect your information

The information we hold about you comes from the way you engage with us such as online through our website, via email, the post, over the telephone or through the contracts between us. We collect information supplied by you during the course of our business relationship. We also collect CCTV images if you visit our premises.

We may also collect details of your visits to our website including traffic data, location data, weblogs and other communications data and the resources that you access.

The type of information we hold

The information we hold includes name, business address, business contact telephone numbers, business email addresses and CVs.

How we use your information

We will lawfully process personal information in the following ways:

- To fulfil the contracts between us including providing you with information you have requested, delivering the contracted services, raising invoices and making payments.
- To record and control access to our building to comply with Health and Safety Legislation.
- For legitimate interest of recording images of those individuals who have entered or attempted to enter our building as it is necessary for us to control access to our building, protect staff and prevent and detect crime.

For the legitimate interest of direct marketing to inform you of our products and services and to invite you to events.

Who we will share your information with

We will not share personal information about you with third parties without your consent unless the law requires us to. We do need to pass on some of this personal data to:

- Our suppliers who are involved in delivering the supply chain.
- Our IT service providers.

Our suppliers are bound by UK privacy law and the terms of the contracts we have with them.

Storing your information

Your personal information will be stored on systems owned or operated by Premier Energy or those of our specific suppliers and will only be stored inside the European Economic Area (EEA), or a country approved by the EU.

Retention

We will retain your personal information in accordance with legal and regulatory requirements. In the case of project related information we must retain your information for 12 years.

For general business contacts we will only retain your information while we are actively engaged with you. Where we have had no interaction with you for a period of 5 years we will delete your data.

How you can access your information

You have the right to request access to the information we hold about you. To make a request for your personal information, please contact the Privacy Manager at info@premierenergy.co.uk.

Your Rights

You have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress;
- have inaccurate personal data rectified.
- request your information to be deleted or destroyed and if we can we will but sometimes
 we must maintain some records for legal reasons.

If you are not happy how we are using your information or how we have responded to your request, you have the right to complain to the Information Commissioner's Office at www.ico.org.co.uk.

Use of cookies

We may use cookies and similar technologies on our website. Cookies are small text files that may be stored on your computer or mobile device when you visit our website. Cookies do many different things, such as letting you navigate between web pages efficiently and remembering your preferences. We use cookies to track your use of our site, but we do not use cookies to make decisions about you or to send you marketing information electronically.
